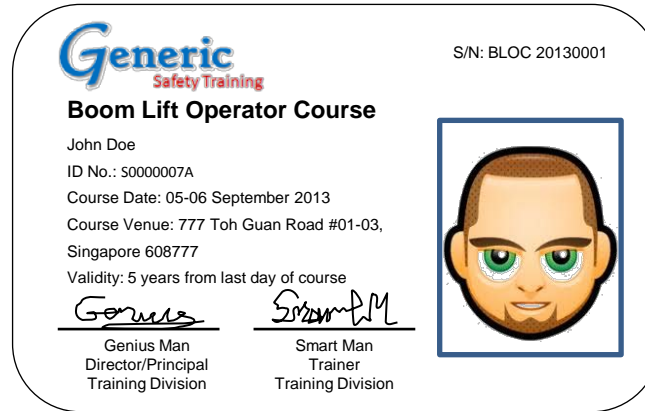


Credit-card sized safety pass

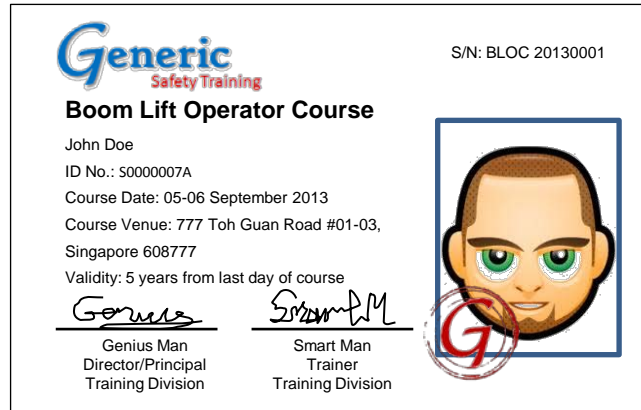
